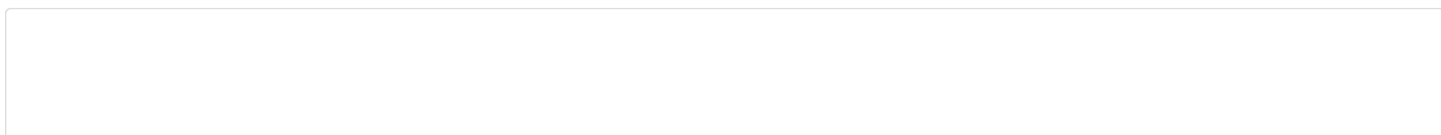

Abdur Rahman Crescent Institute of Science and Technology. All the activities like paper setting, Conduct of examination, Declaration of results and Assessing the examination papers are done inhouse by the Office of the Controller of Examinations, B.S. Abdur Rahman Crescent Institute of Science and Technology. The question papers are set by experts in the respective fields of study. They are chosen from among a panel of experts prepared by the CRESOLINE. This is done directly by the confidential section of the Office of the Controller of Examinations. There shall be one end semester examination of 3hours'duration for each theory course. The examinations shall ordinarily be conducted between May and July during the odd semesters and between November and January in the even semesters. For the practical examinations (including project work),both internal and external examiners shall be appointed by the Controller of Examination. The end semester evaluation of the Project work will be based on the project report and a Viva- Voce Examination by a team consisting of the guide and External Examiner(s) who are appointed depending on the chosen areas of specialization of the students. The External Examiner(s) shall be appointed by the Controller of Examinations, B.S. Abdur Rahman Crescent Institute of Science and Technology Chennai. If a student indulges in malpractice in any of the end semester / internal examinations, he / she shall be liable for punitive action as prescribed by the Director , Academic Courses as per the Institution regulations from time to time. The End semester examinations are conducted by the Office of the Controller of Examinations, B.S. Abdur Rahman Crescent Institute of Science and Technology Chennai as per the method followed for regular programmes. The Examinations are conducted various study center/ colleges in the region throughout the country by appointing a Chief Superintendent who in turn conducts the examination with the Hall invigilators from among the faculty of local colleges. The overall conduct is supervised by the B.S.
